

## Privacy Statement

Letsap Business Solutions is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Letsap Business Solutions Web site and governs data collection and usage. By using the Letsap Business Solutions website, you consent to the data practices described in this statement.

### Collection of your Personal Information

Letsap Business Solutions collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Letsap Business Solutions also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Letsap Business Solutions. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by Letsap Business Solutions for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Letsap Business Solutions Web site.

### Use of your Personal Information

Letsap Business Solutions collects and uses your personal information to operate the Letsap Business Solutions Web site and deliver the services you have requested. Letsap Business Solutions also uses your personally identifiable information to inform you of other products or services available from Letsap Business Solutions and its affiliates. Letsap Business Solutions may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Letsap Business Solutions does not sell, rent or lease its customer lists to third parties. Letsap Business Solutions may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Letsap Business Solutions may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are

prohibited from using your personal information except to provide these services to Letsap Business Solutions, and they are required to maintain the confidentiality of your information.

Letsap Business Solutions does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Letsap Business Solutions keeps track of the Web sites and pages our customers visit within Letsap Business Solutions, in order to determine what Letsap Business Solutions services are the most popular. This data is used to deliver customized content and advertising within Letsap Business Solutions to customers whose behavior indicates that they are interested in a particular subject area.

Letsap Business Solutions Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Letsap Business Solutions or the site; (b) protect and defend the rights or property of Letsap Business Solutions; and, (c) act under exigent circumstances to protect the personal safety of users of Letsap Business Solutions, or the public.

#### Use of Cookies

The Letsap Business Solutions Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Letsap Business Solutions pages, or register with Letsap Business Solutions site or services, a cookie helps Letsap Business Solutions to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
